#### H.E. FRANCISCA VAN DUNEM - Minister of Home Affairs and Justice, Portugal



Her Excellency Francisca Van Dunem serves as Portugal's Minister of Home Affairs and Justice. Born in Luanda, Angola, she studied law in Lisbon where she later pursued her career as lawyer and politician. Van Dunem's professional activities included several positions as Deputy Public Prosecutor, member of the Principal State Prosecutor's private law firm and Director of the Lisbon Public Prosecution Service. In 2015, Van Dunem joined the national government as Minister of Justice and, since December 2021, she heads both the Ministry of Home Affairs and the Ministry of Justice.

# H.E. RUI ALBERTO FIGUEIREDO SOARES - Minister of Foreign Affairs, Cooperation and Regional Integration, Cabo Verde



His Excellency Dr. Rui Alberto de Figueiredo Soares is Minister of Foreign Affairs, Cooperation and Regional Integration of Cabo Verde. He holds a Ph.D. in Law and a Master's in Psychology and Educational Sciences. He was Deputy of the Nation and Chairman of the Board of the parliamentary group of the Movement for Democracy party. During his career, he served in several high-level government positions and has already held the posts of Minister of Foreign Affairs, Minister of the Presidency of the Council of Ministers, Minister of Health, Secretary of State for Youth and Sports, Cabo Verde's Plenipotentiary Ambassador in Paris, Head of Unit at UNESCO and participated in several field missions, in particular in post-conflict situations.

Ndeye Coumba Diop is the ILO Regional Labour and Mobility Specialist at the ILO regional office for Africa in Abidjan, Côte d'Ivoire, since July 2021. Prior to that, she was ILO Chief Technical Advisor (CTA), managing the ILO-IGAD¹ regional project "Free movement of persons and transhumance in the IGAD region" - Improving opportunities for regular labour mobility – funded by the EU. She also worked many years at the International Training Center of the ILO in the Employment Policy and Analysis Programme – EPAP, developing and implementing capacity-building activities on promoting decent jobs in the informal economy. Coumba holds a Master's degree in Applied Economic Sciences - National school of Applied Economic Sciences - University of Dakar, Senegal (1997-1999); and a Master's degree in Management of Development - University of Turin, Italy (2001-

2002). She is fluent in English, French and Italian - and is an IAF<sup>2</sup> certified professional facilitator since May 2019.

She is the coordinator for the Single Permit Directive and for the external dimension of legal migration as well as part of the team dealing with Talent Partnerships. Monica has a law degree from the Central University of Barcelona.

#### JENNIFER TANGNEY – Migration Partnership Facility (MPF/ICMPD)



Dr. Jennifer Tangney has a background in development cooperation with nearly 20 years of experience working in Africa on civil society, human rights, governance and migration matters. Jennifer has worked for the European Commission and implemented EU-funded grantmaking programmes in several countries supporting policy dialogue, civil society, human rights and other thematic areas. He has worked at the OECD since 2007 in a variety of subjects related to both migration and development, and is an expert on the links between these two policy fields. In addition to international migration, he has led, drafted and published reports on informality, internal migration, urbanisation, social cohesion, well-being, and development strategies. He has been a core author of the OECD's Perspectives on Global Development flagship report since its inception in 2009, and led the team from 2017 to 2019. Sitting on several advisory boards related to migration, he brings the OECD Development Centre's unique expertise and policy circles

into international and regional governance fora, such as the GFMD. He holds a PhD in economics from the Paris School of Economics (PSE).

#### **HARALD HABERMANN – NIRAS-IP Consult**



Harald Habermann has a PhD in entrepreneurship and also holds a MAS in Development and Cooperation. In 2011, he worked as a project assistant for the project "Support of Measures to Strengthen the Peace Process" at GIZ<sup>3</sup> Nepal. He was responsible for conducting and coordinating a labour market analysis for the reintegration of Maoist excombatants.
