- Has your country established a national working group or task force dedicated to addressing cases of missing migrants?

## Support for families

- What measures have been taken to support families of missing migrants?
- Can families report disappearances safely and without fear of reprisals?
- Is there a trusted government or local point of contact for families?

## Child protection and capacity-building

- What training or capacity-building initiatives exist for relevant professionals (police, immigration officials, judges, lawyers, social workers, staff of international and civil society organisations) on child protection - particularly for unaccompanied and separated migrant children?



# HUMANITARIAN FORENSIC ACTION

- The use and application of forensic science to humanitarian activities
- The dead, missing, and their families are at the center of the Forensic activities in the ICRC.
- A priority of forensic science in the humanitarian space is the dignified management of the dead and the resolution of cases of missing persons - Right of the victims' families to know the fate and whereabouts of their loved ones and Restoration of the identity of the deceased.

# MoTD/PoTD

From a forensic perspective, there is **no justification for not following all standard procedures for the recovery, transfer, identification and final disposal of remains of disaster victims.** A small group of experts experienced in these procedures should supervise the process. However, in situations where experts are not available, **the community physician(s) should provide leadership and use all available resources to carry out these tasks.**

# **Basic objectives of MoTD :**

- 1. Legally pronounce death**
- 2. Recover the Human remains**
- 3. Establish the identity of the dead**
- 4. Estimate the time of death**
- 5. Determine the cause of death**
- 6. Explain the possible circumstances leading to death**
- 7. Prepare the remains for final disposal**
- 8. Draw lessons from the event to aid in future prevention.**

# Who is involved?

- Justice/Legal institutions,
- Investigative/Security institutions,
- Administrative institutions,
- Medical systems,
- Armed forces
- Emergency responders (civil protection, firefighters, emergency care teams).

Responsible for the investigation of disappearances, missing person cases and death investigations

# Four phases of MoTD



## Human Remains Recovery

Depending on the incident and where it happened, it can take days or even weeks for all the human remains and their property to be recovered.



## Mortuary

The Mortuary phase is where human remains are examined by forensic specialists, and the recovery of the traditional Primary Identifiers is conducted to provide scientifically robust reference data that can be utilised to provide conclusive identification of a deceased person.



## Missing Person Enquiry

The MPE phase is where the next-of-kin or family of a person suspected as being amongst the fatalities are interviewed.



## Reconciliation, Repatriation and Disposition

Once the Mortuary data and MPE data have been collected and subjected to scientific analysis, a team of specialists, usually comprised of police, legal and forensic (termed as the Identification Commission), will consider each provisional identification made in relation to bodies and body parts.

# **Forensic Human Identification**

- “**Identification is a process** itself rather than a result of the use of a given technique”



## THE FORENSIC HUMAN IDENTIFICATION PROCESS: AN INTEGRATED APPROACH

- “The identification phase of the Search process is also of an investigative nature in which the collection of information from **different sources** is the basis for this reconstruction and the resulting conclusions”

quatrième niveau

- “Information will be compared as independent **lines of evidence**; each including comparable data from different information sources to confirm or refute a hypothesis formulated at the beginning of the identification process”
- “Even in simple cases, the identification must, where practicable, involve several lines of evidence **rather than relying solely on a single technique (i.e. fingerprints, dental, DNA, etc.)**”
- “The Search process must be **multi-disciplinary, objective, integrated, holistic, exhaustive, multi-agency coordinated, and able to withstand peer review**”

# The ID PROCESS

Combines (**primary/scientific** and secondary methods):

- Visual Identification
- Medical History – unique medical conditions
- Unique or combination of multiple characteristics such as scars, marks and tattoos, etc.
- Circumstantial Evidence – Reports, testimonies, etc.
- **Fingerprints**
- **Odontology (Dentistry)**
- **Radiography (Imaging)**
- **DNA analysis**



## Exemple pratique d'identification d'une personne migrante disparue et leçons apprises

# Situation d'un fils camerounais / Situation of a son from Cameroun

**Une mère d'origine camerounaise** vivant en Suisse a contacté notre service car elle a été contactée par un homme ghanéen et une dame camerounaise qui se trouvent tous deux dans un camp de réfugiés en Bosnie. Les deux ont entendu que **son fils de 18 ans est décédé en essayant de traverser une rivière entre la Croatie et la Slovénie ou près d'un village en Bosnie.**

Son fils Adou aurait dû commencer ses études au Cameroun. Contre sa volonté, il a décidé de quitter le Cameroun et faire le voyage jusqu'en Europe.

Après **132 emails** et un nombre important d'appels avec les parties prenantes impliquées, le corps d'Adou a pu être identifié et ses cendres ont pu être remises à sa mère.

**A mother of Cameroonian origin** living in Switzerland contacted our service because she had been contacted by a man from Ghana and a Cameroonian woman who were both in a refugee camp in Bosnia. Both had heard that her 18-years old son had died trying to cross a river between Croatia and Slovenia or close to a town in Bosnia.

Her son Adou was due to start university in Cameroon. Against his will, he decided to leave Cameroon and make the journey to Europe.

After **132 e-mails** and many different calls with all different parties, Adou's body was identified and his ashes given to his mother.

# From reporting a missing person to identification

01.05.2020	<b>Last news of son</b>
14.07.2020	Information through other migrants who knew the son saying that he disappeared in the river Kupa or in Bosnia
15.07.2020	First contact of the family with the Swiss Red Cross
20.07.2020	Request to regional Red Crosses about the possibilities of search along the river Kupa=> Info received that Kupa is at the border between Slovenia and Croatia
20.07.2020	Information about the case of the Swiss Red Cross to the Swiss Federal Police
27.07.2020	<b>Appointment of the mother at local police</b> for the missing person report and collection of the AMD information, accompanied by the Swiss Red Cross
28.07.2020	<b>Transfer of the request AMD</b> to Croatia via channel Interpol and the Federal Police (Fedpol)
30.07.2020	Request Ante Mortem Data also sent to colleagues of the Croatian Red Cross
19.08.2020	Recommendation to the family to <b>organize a psychological support</b>
17.09.2020	Information to the Croatian Red Cross that the body has been identified, transfer of this information to the police
23.09.2020	Confirmation of the police about the <b>identification</b>
09.2020 - 03.2021	Numerous contacts made to resolve the difficulties of transferring the urn
05.03.2021	Lawyer confirms the cremation of the body on 09.03.2021
03.2021	<b>Transfer of the urn via the undertaker</b>
23.03.2021	The urn is in the hands of the mother in Switzerland
2024	After keeping the urn at her home for several years, the mother decided to bury them in the cemetery of her commune of residence
2024	Request for a <b>death certificate</b> after meeting with the family for an assessment. The Croatian Red Cross was recently contacted on this subject.

# Bonnes pratiques autorités / Good practices authorities

## Au niveau national:

- Groupe de travail national établi (par Engagement Croix-Rouge) et rencontre régulières
- Analyse des cas/demandes concrètes
- Compréhension approfondie sur le fonctionnement des autres parties prenantes (par exemple Yellow Notice, I-Familia)
- Identification des points focaux dans chaque organisation (par exemple les Bureaux centraux nationaux d'Interpol auprès des Polices nationales)

## Au niveau local:

- Information des forces de l'ordre par la fiche d'information nationale
- Préparer les autorités locales pour l'entretien, clarifier qui fait quoi entre avis de disparition, prélèvements ADN etc.

## On national level:

- National working group established (through pledge of the RC conference)
- Analysis of concrete requests/cases
- Deep comprehension about the way of working of the other stakeholders (e.g. Yellow Notice, I-Familia)
- Identification of focal points in each organization (e.g. the National Central Bureaux of Interpol at the national police)

## On local level:

- Information of all police staff members through national information sheet
- Prepare local police for the interviews, clarify who is doing what (missing persons report, taking DNA samples etc).

# Bonnes pratiques pour les familles / Good practices for the families

- Accueil/Information/Préparation de la famille => Entretien et fiche d'information
- Prise de décision libre sur le choix des voies de recherches
- Accompagnement de la famille à la police (incl. interprétariat)
- Recommander/aider à organiser un soutien psychologique
- Coopération avec d'autres acteurs/trices
- Welcome/Information/Preparation of the family => Meeting and information sheet
- Free decision of the family to choose the way of tracing
- Accompany the family to the police (incl. Interpreter)
- Recommend/Help organizing a psychological support
- Cooperation with other involved stakeholders

## Pour les familles qui ne trouvent pas:

- Etre à l'écoute de leurs besoins
- Organiser des espaces d'échange (groupes de parole, événements)
- Proposer aux accompagnants l'E-Learning sur la perte ambiguë (*Ambiguous Loss*)

## For the families who do not find:

- Listening to their needs
- Organizing events for exchange between the families
- Propose to accompanying persons the E-Learning “Ambiguous Loss”



# Context & Scope

JVAP database tracks **3,446 initiatives (2015–2024)**.

Only **32 address missing migrants.**

**€257.4 million mobilized.**

Insights from the JVAP Database on Preventing and Resolving Cases of Missing Migrants (2015-2024)<sup>1</sup>

**Overview**

The Rabat Process partner countries and key stakeholders meet in Banjul, The Gambia, against a sobering backdrop: in 2024 alone at least 9,002 people have died or gone missing along mixed-migration routes, the highest annual total since records began in 2014. Objective 5b of the Cádiz Action Plan – reinforced by Action 17 – commits partners to prevent such tragedies, locate and identify the missing and support their families. A review of the Joint Valletta Action Plan (JVAP) database shows that 32 of the 3,446 recorded actions between 2015 and 2024 address at least one phase of this response chain and mobilise some €257.4 million. They have delivered measurable gains: desert and maritime search-and-rescue (SAR) corridors, new forensic laboratories, digitised civil registries and family-assistance centres. Yet four structural gaps persist – fragmented data standards, under-funded family services, uneven route coverage and short-term financing – all of which require attention in Banjul to consolidate progress into a coherent, route-based architecture.


**Context and Purpose**

The Rabat Process was founded on principles of solidarity and shared responsibility. Nearly two decades on, partners confront a humanitarian toll that underscores the urgency of those principles: every 58 minutes, on average, a person disappears while attempting to cross the Sahara, the Atlantic or the Mediterranean. The Banjul meeting is the first in-person gathering of formally appointed National Focal Points (NFPs) for Missing Migrants. Therefore, there is need for a concise, evidence-based picture of what has been undertaken to date under the JVAP framework, i.e. where resources are presently concentrated and which corrective measures can maximise impact in the next programme cycle. This analytical note distils 10 years of monitoring data into policy-relevant findings intended to inform both plenary debate and technical break-out sessions.




