#### I - HISTORICAL BACKGROUND

### A. FROM 1960 TO 1990, PERIOD OF RELATIVELY MODERATE REFUGEE FLOWS TO CÔTE D#IVOIRE

- GUINEAN REFUGEES, FIRST REFUGEES WELCOMED IN THE CÔTE D'IVOIRE, DUE TO THE POLITICAL CONTEXT IN THIS COUNTRY
- A FEW THOUSAND NIGERIAN REFUGEES, ORIGINALLY FROM THE REGION OF BIAFRA, FLEEING THE CIVIL WAR BETWEEN THIS REGION AND THE NIGERIAN STATE
- REFUGEES FROM CAMBODIA, THE DRC, REPUBLIC OF THE CONGO

OBSERVATION: NO PERMANENT STRUCTURE FOR MANAGING REFUGEES



#### B. AFTER 1990, PERIOD OF MASSIVE REFUGEE FLOWS TO CÔTE D'IVOIRE

- 1990, CRITICAL YEAR AS CÔTE D'IVOIRE WELCOMES HUNDREDS OF THOUSANDS OF REFUGEES FOR THE FIRST TIME
- 400,000 LIBERIAN REFUGEES FLEEING THE WAR IN LIBERIA
- 45,000 REFUGEES FLEEING THE WAR IN SIERRA LEONE
- DOZENS OF RWANDAN REFUGEES FLEEING THE CIVIL WAR IN RWANDA
- IN 2007, REFUGEE STATUS CESSATION OF CLAUSE FOR SIERRA LEONEANS
- JULY 2012, REFUGEE STATUS CESSATION CLAUSE FOR LIBERIANS
- SINCE PEACE RETURNED TO LIBERIA AND SIERRA LEONE AND THESE TWO CESSATION CLAUSES, WERE IMPLMENTED, CÔTE D'IVOIRE NOW ONLY HOSTS 1,822 REFUGEES.

**OBSERVATION:** THE MAJORITY OF LIBERIAN REFUGEES WERE HOSTED BY IVORIAN FAMILIES DUE TO THE ETHNIC PROXIMITY BETWEEN THE POPULATIONS OF THE 2 BORDER AREAS

#### **II - OPERATIONAL CONTEXT**

- CREATION OF AN INTER-MINISTERIAL COMMITTEE IN 1990, MANAGED BY THE MINISTRY OF THE INTERIOR, TO MANAGE EMERGENCIES RELATED TO THE INFLUX OF LIBERIAN REFUGEES
- CREATION OF THE NATIONAL COMMITTEE FOR COORDINATION AND SUPPORT OF LIBERIAN REFUGEES (CNCARL) IN 1992, 1<sup>ST</sup> PERMANENT STATE STRUCTURE FOR MANAGING REFUGEES IN CÔTE D'IVOIRE
- 1992, SEAT AGREEMENT BETWEEN CÔTE D'IVOIRE AND UNHCR
- CREATION OF THE DEPARTMENT OF AID AND ASSISTANCE FOR REFUGEES AND STATELESS PERSONS IN 2000

#### A. LEGAL BASES FOR ASYLUM AND INTERNATIONAL PROTECTION

- IVORIAN CONSTITUTION OF 1<sup>ST</sup> AUGUST 2000
- 1951 GENEVA CONVENTION RELATING TO THE STATUS OF REFUGEES, RATIFIED ON 8 DECEMBER 1961
- 1969 OAU CONVENTION GOVERNING THE SPECIFIC ASPECTS OF REFUGEE PROBLEMS IN AFRICA, SIGNED BY CÔTE D'IVOIRE ON 10 SEPTEMBER 1969, SUBMITTED ON 26 FEBRUARY 1998 AND RATIFIED ON 20 APRIL 1998

**OBSERVATION**: WEAKNESS IN OUR LEGAL FRAMEWORK IN THIS RESPECT DUE TO LACK OF INTERNAL ASYLUM. SOLUTION IN PROGRESS: DRAFT LEGISLATION ON ASYLUM IN PROCESS OF BEING ADOPTED

#### **B. OPERATIONAL PROCEDURES**

PRIMA FACIE OR GROUP RECOGNITION INDIVIDUAL RECOGNITION

FOR INDIVIDUAL RECOGNITION:

- STATUS APPLICATION TO THE NATIONAL COMMISSION ON ELIGIBILITY FOR REFUGEE STATUS
- APPEAL TO THE REFUGEE STATUS APPEALS COMMISSION
- APPEALS FOR ULTRA VIRES BEFORE THE SUPREME COURT

**FINAL OBSERVATION:** INTERNAL LEGAL FRAMEWORK FOR ASYLUM AND INTERNATIONAL PROTECTION TO BE COMPLETED
